Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information you provide to Gamer.

You understand that:

1. Gamer is the party who is collecting your personal information and can be contacted at [contact@gamer.com.au](mailto:contact@gamer.com.au) or alternatively you can write to us at PO Box 312, Archerfield Qld 4108.
2. Gamer will collect your personal information directly from you. In certain circumstances, Gamer may be required to collect personal information from third parties, depending on the nature of your enquiry.
3. The purpose of Gamer collecting your personal information is:
  - a. to process your purchase order of our goods or services by you and the administration management and provision of those goods and services to you, including without limitation verifying your identity, processing payment for the purchase, including charging or credit card authorisation, verification and debt collection;
  - b. to process any sales related enquiry you may have and provide you with information in relation to your enquiry, including without limitation, verifying your identity, assisting you with payment queries;
  - c. to provide customer service functions, including handling customer enquiries and complaints including submitted via the "Contact" page of the Gamer website;
  - d. to offer you updates, discounts, or other content or products and services that you request information on and, if you hold an account with our website, to provide you with direct marketing communications from us or our related entities and associates (using direct mail, telemarketing, email, SMS and MMS messages);and you acknowledge and agree to your personal information being collected and used for, and in connection with, these purposes and any other purpose described in our Privacy Policy.
4. If we do not collect this personal information in connection with the purposes in paragraph 3, then:
  - a. Gamer will be unable to process your purchase order and provide our goods and services to you;
  - b. we will be unable to provide you with customer services, process your enquiry or complaint, or supply you with information in relation to enquiry; and
  - c. we will be unable to send you direct marketing communications (unless you have consented to such communications through your other dealings with Gamer).
5. Your personal information may be disclosed to the following classes of people and organisations in connection with the purposes in paragraph 3:
  - a. Gamer its personnel and any related entities;
  - b. third party service providers including without limitation marketing service providers, IT service providers, contractors and sales consultants and other parties who assist us in providing our products and services to you;
  - c. third parties connected with the sales and after sales process including, ecommerce services and financial institutions; and
  - d. any other organisation as expressly covered in our Privacy Policy.
6. It is possible that some of the information collected may be disclosed to Gamer's related body corporate or service providers outside of Australia. You consent to your information being disclosed to a destination outside Australia for this purpose, including but not limited to the United States of America and you understand and acknowledge that Australian Privacy Principle 8.1 will not apply to such disclosures of your personal information.
